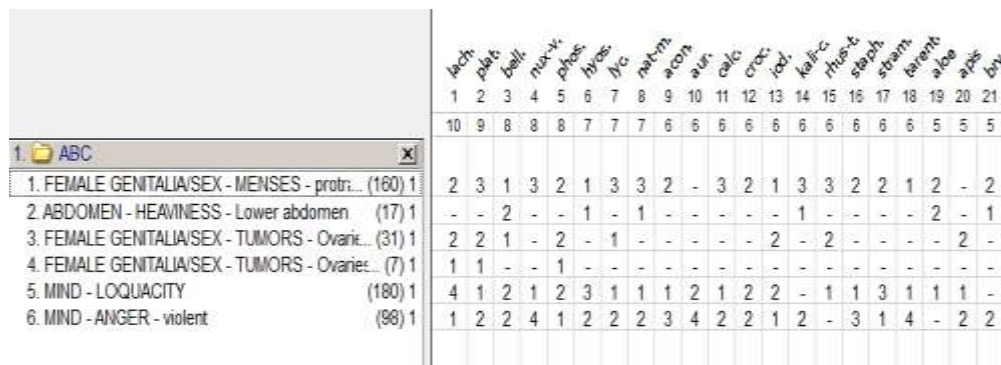


Figure 1 Showing Repertorization

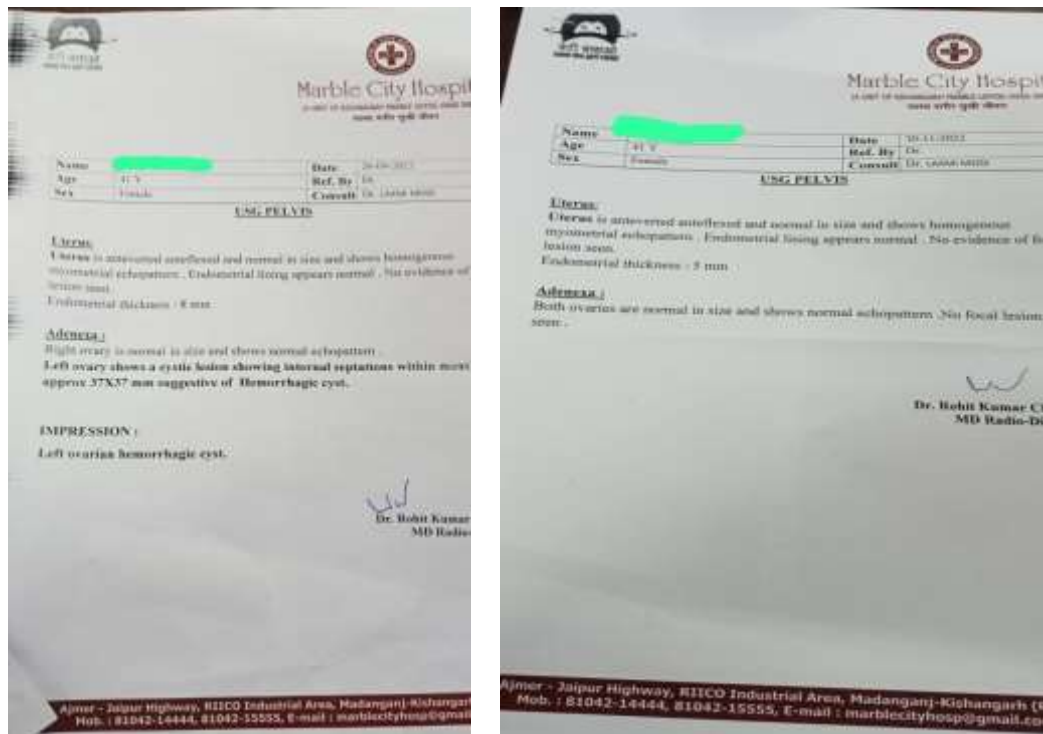


Figure 2 Report Before and After Treatment
