Content of this message:

- Adjustment of the already communicated transitional regulation concerning the submission of Transaction Reports for Swiss Domestic Securities Dealers

---

In order to allow those subject to the duty to report sufficient time to implement the new aspects of the reporting duty, the deadline for submitting Transaction Reports has been postponed. This concerns only Transaction Reports which were to have been submitted for the first time as of 1 January 2018, in accordance with the [SIX Swiss Exchange Reporting Office Rules \(Reporting Rules\)](#). Existing obligations to submit Transaction Reports are not affected. Those subject to the duty to report **still have the option of fulfilling their reporting obligations in full as of 1 January 2018**.

**Latest from 1 October 2018 onwards, Swiss Domestic Securities Dealers** have to comply with all aspects of their reporting obligations, as set out in the Reporting Rules and the SIX Swiss Exchange Rule Book regarding Article 129 paragraph 1bis FMIO. This includes details of the beneficial owner and Transaction Reports concerning trades and transmissions of orders in security-based derivatives.

Incomplete or not submitted Transaction Reports of Swiss Domestic Securities Dealers during the period from 1 January 2018 to 30 September 2018 are required to be retroactively submitted as full reports no later than 31 December 2018 ("Backloading").
