In [SIX Swiss Exchange message no. 09/2018](#), SIX Swiss Exchange informed Participants about the start of the Membertest phase of the optional SWXess Maintenance Release 7.1 (SMR7.1), which primarily implements the new orders "Iceberg Plus" and "Limit Plus" for trading in the order book and in SwissAtMid.
