- SMR7.2 is an optional maintenance release of the SWXess trading platform
- Initial publication of “SMR7.2 – Participant Readiness” brochure
- Publication of first versions of SWXess Interface Specification documents
- Rollout plan of SMR7.2 in Membertest environment **20 August 2018** and in Production environment **15 October 2018**

SIX Swiss Exchange is launching another upgrade of its SWXess trading platform as part of its ongoing optimization efforts. SWXess Maintenance Release 7.2 (SMR7.2) is **optional for SIX Swiss Exchange participants** and comprises expansions and optimizations in the field of trading in the order book and without pre-trade transparency, as well as in the bilateral, off-exchange trading of structured products. SMR7.2 also lays the groundwork for the replacement of the MDI market data interface by the SIX MDDX Multi-Dimensional Data fluX™ (SIX MDDX) interface for participants.

SMR7.2 is scheduled to go into the **Membertest environment on 20 August 2018 and 15 October 2018 in the Production environment**. The contingency date for the go-live in Production is 12 November 2018.

Please find all of the business-related information regarding SMR7.2 that is currently available in the brochure “[SMR7.2 – Participant Readiness](#)”, which is being published together with this announcement. The brochure contains information about the functional changes and regulatory effects of SMR7.2 as well as details concerning the migration, test phase and rollout. It also contains references to other documents that are relevant for SMR7.2.
