This message from SIX Swiss Exchange is to inform participants about the amendments to the trading parameters in the “Blue Chip Shares” trading segment as of 1 October 2019.

### Introduction of delayed opening for the Blue Chip Shares trading segment

Currently, SIX Swiss Exchange Ltd does **not** extend the auction time at the opening (Delayed Opening) for Blue Chip Shares.

At the request of participants, as of **1 October 2019** SIX Swiss Exchange Ltd is introducing a delayed opening for the “Blue Chip Shares” trading segment. The auction time at opening (Delayed Opening) will be extended once **by 5 minutes** if the calculated opening price differs by **1.5%** or more from the reference price.

### Trading Parameters Guideline

The Trading Parameters Guideline of SIX Swiss Exchange Ltd has been amended to take into account the introduction of the Delayed Opening for Blue Chip Shares.
