With SWXess Maintenance Release 8.1 (SMR8.1), SIX has introduced significant changes to the Transaction Reporting Interface in Swiss Format (TRI CH-Style). These changes included amendments to the reporting of information about the Beneficial Owner.

This message informs participants about additional changes in the Transaction Reporting Interface in Swiss Format (TRI CH-Style) for the reporting of special Beneficial Owner constellations.

Functional Change

SIX will introduce a **new Beneficial Owner Type Code (BOTC) “DSC”** (Defined Special Constellation) in the Beneficial Owner attribute of the Transaction Report file. Please note that BOTC “DSC” is **only allowed, if no Beneficial Owner Data of a natural person, LEI, BIC, CRN, MEMB or UID is available**. Therefore its use is strictly **subsidiary** to other and existent Beneficial Owner Type Codes.

This new Beneficial Owner Type Code for Transaction Reporting in Swiss Format (TRI CH-Style) allows participants to report the predefined Beneficial Owner special constellations as follows:

Please note that SIX will validate in the Transaction Report Interface (TRI CH-Style) that only defined special Beneficial Owner constellations are submitted; all non-defined special constellations will be rejected.

Participants are required to report special Beneficial Owner constellations with the new Beneficial Owner Type Code "DSC" from the go-live of the new Transaction Reporting Interface in Swiss Format in the Production environment on 17 August 2020.

The Transaction Reporting Interface Specification (TRI CH-Style) versions mentioned in the table above will be consolidated into version 4.8.0 from 31 January 2020 for simplicity reasons and to reduce complexity and maintenance effort for participants as well as for SIX. All participants must therefore migrate to the new version 4.8.0 as of this date.

The introduction of the change in the Transaction Reporting Interface in Swiss Format is scheduled as follows:
