

RESOLUTION

ESTABLISHING SISTER-CITY RELATIONS BETWEEN THE CITY OF TOKYO, JAPAN AND THE CITY AND COUNTY OF HONOLULU.

WHEREAS, it is our national policy to develop mutual trust and goodwill among the peoples of the world through a Sister-City Program; and

WHEREAS, the point of origin of many valued and prominent citizens and families of the City and County of Honolulu is Japan, and Tokyo is both the Capital of Japan and its commercial, education and cultural center; and

WHEREAS, the Honorable Shunichi Suzuki, Governor of Tokyo Metropolis, has expressed his enthusiastic support of a Sister-City relationship between Tokyo and the City and County of Honolulu as proposed by the Honorable Rudy Pacarro, Chairman of the Honolulu County Council; and

WHEREAS, such a Sister-City relationship benefits the people of the affiliated cities through the exchange of information on city development, cultural exhibits, educational programs, mutual assistance in developing and fostering the tourist industry, and through exchange visits of citizen groups as well as of government officials; and

WHEREAS, the City and County of Honolulu would be both pleased and honored to establish a Sister-City relationship with the City of Tokyo and the good people thereof; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu, State of Hawaii, United States of America, that a Sister-City relationship to become effective on December 8, 1982, is hereby established between the City of Tokyo, Japan, and the City and County of Honolulu; and
